## **DATA WE COLLECT**

If you provide it to us, we will collect personal identification information (Name, email address, phone number, etc.)

We may also collect a response to a multiple choice question, that broadly describes your situation.

## **HOW WE COLLECT YOUR DATA**

You directly provide Market Makers with the data we collect. We collect data and process data when you:

- Register online for our services
- Voluntarily complete a survey of provide feedback on any of our message boards, social media accounts, or via email
- When you call us
- Use or view our website via your browsers cookies

### **HOW WE WILL USE YOUR DATA**

We collect your data so that we can:

- Establish your eligibility for ESF or ERDF funding
- Tell you about events and services we think you may like
- Provide you with relevant support if applicable

### **HOW WE STORE YOUR DATA**

In Liskeard town hall offices, digital information is stored on password protected worksheets, accessible only by password protected desktop PCs located in locked offices. Paper records are in the same office, in a locked filing cabinet.

#### YOUR DATA PROTECTION RIGHTS

We would like to make sure you're fully aware of your data protection rights. Every individual is entitled to the following:

**The right to access:** You have the right to request Market Makers to provide copies of your personal data. We reserve the right to charge a small administrative fee for this service.

The right to rectification: You have the right to request that Market Makers correct any information that you believe is inaccurate. You also have the right to request Market Makers to complete information you believe is incomplete.

**The right to erasure:** You have the right to request that Market Makers erase your personal data, under certain conditions.

The right to restrict processing: You have the right to request that Market Makers restrict the processing of your personal data, under certain conditions.

The right to object to processing: You have the right to object to Market Makers processing of your personal data, under certain conditions.

**The right to data portability:** You have the right to request that Market Makers transfer the data that we have collected to another organisation, or directly to you, under certain conditions.

If you make a request, we have one month to respond to you. If you would like to exercise any of these rights, please contact us
